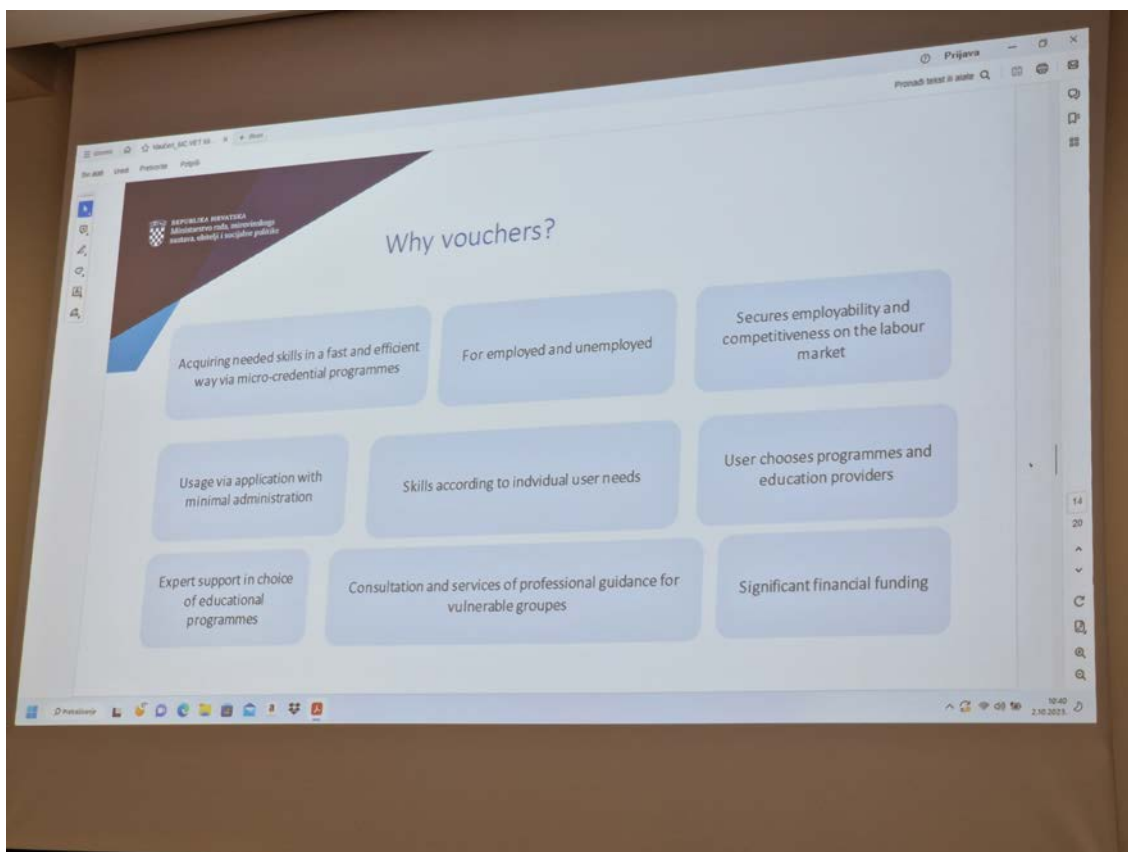
MICRO-CREDENTIALS AND VOUCHERS SYSTEM

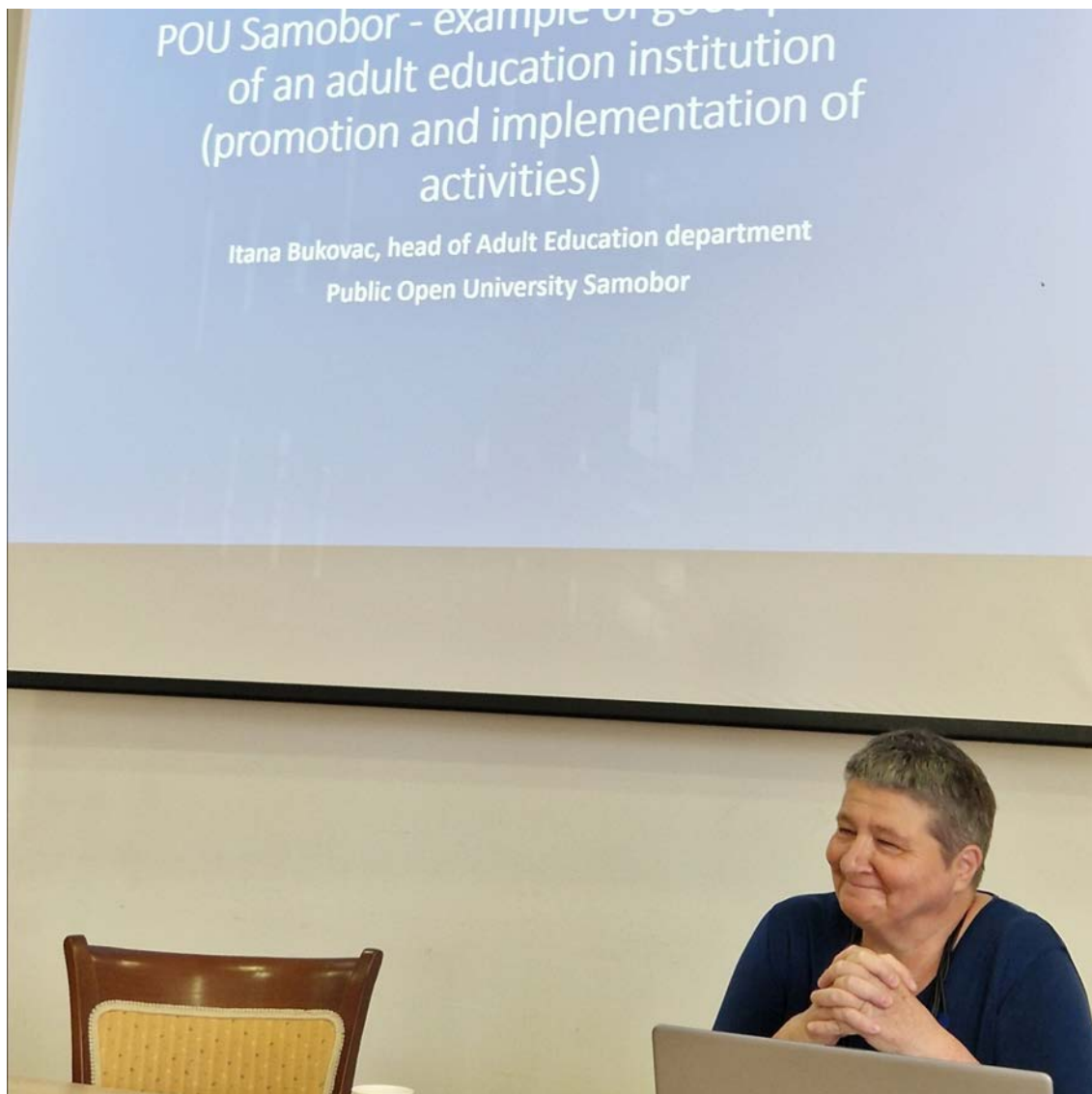
